Teach-out Agreements*

Teach-out agreements are written plans between Hodges University and another university to provide equitable treatment of students and reasonable opportunities for students to complete their degree program. Through these agreements, Hodges students are afforded special conditions. Students are encouraged to work with each university and program to ensure they receive all agreement benefits.

Following is the list of Universities that have signed agreements with us, with details of the agreement per program. For additional information please call HU.

Florida SouthWestern State College (FSWC):

- FSWSC will waive initial institutional admission application fees for Hodges students in good academic standing applying through this teach-out agreement.
- Students applying through the teach-out agreement will qualify as a resident for tuition at all FSWSC campuses and centers.
- FSWSC will offer only those courses of study for which it is already approved.
- FSWSC will accept all earned credit awarded by Hodges University. All transcripted courses accepted, may not meet specific FSWSC degree requirements.

National Louis University (NLU):

- NLU will waive admission application fees for students applying through the teachout agreement.
- Students will be billed at the lower of Hodges' tuition rates or NLU's tuition rates for classes at the Tampa campus and/or Online.
- NLU will suspend its credit hour residency requirement for Hodges students transferring under this Agreement.
- NLU will offer only those courses of study for which it is already approved and in good standing with all regulatory bodies.
- NLU will accept all earned credit.
- NLU will accept only students who are in good academic standing as of 09/15/2023.

Nova Southeastern University (NSU):

NSU will waive admission application fees for students applying through the teach-out agreement.

Clinical Mental Health Counseling Program

- A maximum of 36 credits may be accepted for MS Counseling: Clinical Mental Health Counseling Concentration.
- Clinical Mental Health Counseling program tuition will not exceed \$8,700 per semester.
- Student services fees and textbooks are additional.

BS Nursing

- Current BSN students in the August 2024 HU Cohort will transfer to NOVA as a cohort to complete their Program.
- NSU will not exceed the BSN core program tuition (\$17,200) per semester.
- Student services fees and textbooks are additional.

Masters of Business Administration

- A maximum 18 credits may be accepted to the MBA, not to exceed 50 % of the degree.
- MBA graduate tuition will not exceed \$830.00 per credit hour.
- Student services fees and textbooks are additional.

Other Undergraduate Programs

- A maximum of 96 credits towards select undergraduate degree requirements may be accepted.
- For undergraduate courses NSU will not exceed \$595 per credit hour.
- Student services fees and textbooks are additional.
